Summary:	<p>Article 27: BVT Stabilization Fund Summary: Approves the creation of a stabilization account for Blackstone Valley Vocational Regional School District. Motion: Mike A motion to recommend to the town this article, which Billy seconded. Vote Outcome: The favorable recommendation was approved with support from a majority of the Committee; Mike K dissented.</p> <p>Article 18: Solid Waste and Recycling Budget Summary: Appropriates funds to operate the municipal subscriber curbside trash and recycling services as an enterprise fund. Motion: Jesse motioned to recommend to the town this article, which Billy seconded. Vote Outcome: The favorable recommendation was approved unanimously.</p> <p>Article 13: Fire Station Garage Doors Summary: Appropriates funds to purchase new garage doors for the Fire Station. Motion: Mike A motioned to recommend to the town this article, which Billy seconded. Vote Outcome: The favorable recommendation was approved unanimously.</p> <p>Article 28: Fire Department SCBA Fund Summary: Transfers funds for future purchase of self-contained breathing apparatus for the Fire Department. Motion: Mike A motioned to recommend to the town this article, which Billy seconded. Vote Outcome: The favorable recommendation was approved unanimously.</p>

Article 19: Valuation Account

Summary: Appropriates funds for the Update Valuation Account.

Article 20: Cyclical Inspection Account

Summary: Appropriates funds for the Assessor's Cyclical Inspection Program.

Article 4: Chapter 90 Funds

Summary: Appropriates funds provided by the Commonwealth for local road mileage, population, and employment.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 12: Snow and Ice Removal Deficit

Summary: Appropriates funds to cover the fiscal 2025 snow and ice removal deficit.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 21: MURSD Roof Debt Authorization

Summary: Approves borrowing for roof replacement at Nipmuc Regional High School, including MSBA reimbursement.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 22: MURSD Facilities Debt Authorization

Summary: Approves borrowing for various upgrades and remodeling projects in the District's four schools.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 23: MURSD Fields and Grounds Debt Authorization

Summary: Approves borrowing for renovating and constructing outdoor recreational facilities at Nipmuc Regional High School and Miscoe Hill Middle School.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 24: CPA MURSD Fields Debt Payment

Summary: Transfers funds from the Community Preservation Accounts to fund field work for MURSD fields.

Outcome: The Committee wanted more information to make a recommendation to the Town; Jeremy was going to follow up with Anne and the Committee will meet on 05/02/2025 prior to the Annual Town Meeting to make a recommendation.

Article 1: Affirm Balanced Budget

Summary: Ensures adherence to funding sources for all appropriations to maintain a balanced budget.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 2: Salaries for Elected Officials

Summary: Maintains current stipends for elected officials and provides a 3% cost-of-living increase for the Town Clerk's salary.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 3: Prior Year Bill Payments

Summary: Pays \$557.90 in unpaid invoices from fiscal year 2022 due to a transposition error.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 7: CPA Police Station Debt Service

Summary: Allocates CPA funds to pay annual debt service for the Police Station construction.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 8: CPA Budget Allocations

Summary: Sets 10% minimum allocations for preservation, open space, and historic resources, with 65% budgeted reserve for flexible use.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 9: CPA Affordable Housing Coordinator

Summary: Allocates \$15,000 in CPA funds to support a newly created Affordable Housing Coordinator position.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 10: Insurance Repayments

Summary: Allocates \$18,823 from free cash to reimburse health insurance over-deductions for a retired employee.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 11: Water Study Reclassifications

Summary: Reallocates \$65,350 to cover the deficit caused by incorrect invoice charges to a state grant.

Motion: Jesse motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

Article 14: Police Matching Grant Funds

Summary: Appropriates funds for Police Department State/Federal General Matching Grants.

Motion: Mike A motioned to recommend to the town this article, which Billy seconded.

Vote Outcome: The favorable recommendation was approved unanimously.

	<p>Article 15: General Fund Budget Summary: Approves the fiscal year 2026 General Fund Budget for town operations. Motion: Mike A motioned to recommend to the town this article, which Billy seconded. Vote Outcome: The favorable recommendation was approved unanimously.</p> <p>Article 16: Water Enterprise Fund Budget Summary: Approves the fiscal year 2026 water enterprise budget, balanced at \$227,000, with \$20,000 from retained earnings. Motion: Mike A motioned to recommend to the town this article, which Billy seconded. Vote Outcome: The favorable recommendation was approved unanimously.</p> <p>Article 17: Revolving Fund Spending Caps Summary: Updates annual spending caps for revolving funds, increasing Parks cap to \$250,000. Motion: Mike A motioned to recommend to the town this article, which Billy seconded. Vote Outcome: The favorable recommendation was approved unanimously.</p> <p>Article 25: ARMUD Additional Parcels Summary: This article proposes amending Mendon Zoning By-laws Article V Section 5.05 (Age Restricted Mixed Use Overlay District) and corresponding map to include 3 North Ave (8-177-6-0) and 6 Milford St (8-177-6-0). Motion: Jesse motioned to recommend to the town this article, which Billy seconded. Vote Outcome: The majority of the Committee abstained. Consequently, no recommendation was made due to the lack of majority support. Mike K voted Yes; Nick C voted No.</p>
